PSC Waiver

THIS AGREEMENT WILL AFFECT YOUR LEGAL RIGHTS. READ IT CAREFULLY BEFORE SIGNING!

Description of Risk, Release of Liability, Waiver of Claims, Assumption of Risk & Indemnity Agreement

In consideration of Professional Singles Club (hereinafter referred to as the PSC) accepting my application for and permitting me to participate in club activities which include but are not limited to, social activities such as dances, dinners and other club meetings of any kind at private or public locations, sports activities such as golf, volleyball, tennis, curling, skating, skiing, cycling, snowshoeing, canoeing, swimming, backpacking, hiking, walking, scrambling, camping or any other sports, and travel by plane, car, bus, boat, train motor cycle, bicycle or any other means of transportation, or any other activities or any combination of these or similar activities (collectively referred to below as a "PSC Activity"), the following waiver of all claims, release from all liability, assumption of all risks, agreement not to sue and other terms of this agreement ("PSC Waiver") are entered into by me with and for the benefit of the PSC and the "PSC Personnel" (as defined below).

A PSC Activity: is defined as a social and/or sports activity to start at the location or locations where the social and/or sports activities are planned to take place and end when the participant leaves that location or locations. If the Activity involves travel it is defined as starting at the location where group assembles to commence the travel and ends when the group arrives at the planned end location. This waiver is not to be construed as a release of a driver of any vehicle with respect to any cause of action that may arise as a result of the operation or use of a motor vehicle.

I, on behalf of myself, my next of kin, my heir, executors, administrators and assigns hereby waive any and all claims that I have or may in the future have against, and release from all liability and agree not to sue, the PSC, and any of their club members, activity organizers, activity leaders, activity participants, volunteers, directors, officers, servants, agents, representatives or independent contractors, including any paid instructors or guides, (herein collectively referred to as, the "PSC Personnel") for any personal injury, death, property damage or other loss that I sustain during or as a result of any PSC Activity due to any cause whatsoever on the part of any one or more of the PSC, the PSC Personnel or others, including:

- (a) negligence (the meaning of which includes failure to use such care as a reasonably prudent and careful person would use under similar circumstances and failure to meet any safety standards of care);
- (b) breach of any other duty imposed by law, including any duty imposed by occupiers liability or other legislation;

(c) breach of any contract;

(d) mistakes or errors in judgment of any kind; and

(e) my impairment to safely operate a motor vehicle due to use of alcohol and/or drugs during and after PSC Activities.

I am aware of the risks inherent in PSC Activities, including but not limited to :

PHYSICAL ACTIVITIES – such as playing golf, volley ball, tennis, walking, hiking, biking, skiing, cross country skiing, dancing and any other physical activities. Risks include, but are not limited to: hitting other participants, slippery surfaces, uneven surfaces, hitting obstacles, falling, use of equipment to participate in sports activities, failure of equipment, and consumption of food and beverages.

CONSUMPTION OF ALCOHOL MEDICATION AND DRUGS - I undertake that if I consume alcohol and /or medication and drugs at any Activity I will do so only in moderation and in insufficient quantity to affect my ability to drive a motor vehicle as I appreciate that drinking and driving is dangerous. I realize that a combination of alcohol, medication and drugs can cause unexpected side effects that can severely affect my ability to operate a motor vehicle and others modes of transportation such as motor bikes, bicycles and golf carts. I will arrange in advance of the Activity alternate transportation home should it be required because I have failed in my undertaking. I will be responsible for any other party with whom I have come to the Activity so as to ensure they do not drive while their inability to do so is impaired by alcohol and/or drugs. I will accept full responsibility for my own actions and do not anticipate that the PSC will be vigilant as to my condition during the Activity and accept that the PSC will not have any responsibility for my welfare.

EQUIPMENT: equipment used for PSC Activities may fail.

WEATHER: weather conditions may be extreme and can change rapidly without warning and may cause injury or death.

WILD AND DOMESTIC ANIMALS: which are unpredictable in nature and may attack regardless of location.

PSC, ITS VOLUNTEERS, OTHER PARTICIPANTS AND OTHERS: the conduct, including negligence, of PSC or the Personnel and of all others whether they are associated with PSC or not or others who are independently at the same location;

I assume and accept all the risks and dangers inherent in PSC Activities and the possibility of personal injury, death, property damage or other loss as a result. I agree that, although PSC and the Personnel may take precautions to reduce the risks and increase the safety of PSC Activities, I willingly accept these risks and agree to the terms of this PSC Waiver and agree to waive my legal rights, even if PSC or any of the Personnel are found in law to be negligent or in breach of a duty of care or any other obligation to me in their conduct during a PSC Activity.

In signing this PSC Waiver, I am not relying on any oral, written or visual statements of any kind, including promotional statements made by PSC in their documents or website or by any of the Personnel to induce me to participate in a PSC Activity.

I agree that the PSC Waiver and the agreements it contains will be governed exclusively in all respects by and interpreted solely in accordance with the laws of the Province of Alberta. I hereby irrevocably submit to the exclusive jurisdiction of the courts of the Province of Alberta and I agree that no other courts can exercise jurisdiction over the agreements and claims referred to herein. Any litigation pertaining to this agreement or arising out of my participation in PSC Activity shall be instituted in Alberta and nowhere else.

I confirm that I am of the full age of eighteen years, that I have had sufficient time to read and have read and understood what I am agreeing to in this PSC Waiver before signing it and that it will be binding upon my heirs, next of kin, executors, administrators and successors.
